Highway Department – Supervisor Bryan noted that the County is catching up on its billing. All culverts are in place and we'll allow the ground to settle prior to patching.

Planning Commission – no update.

Issues to be reviewed and/or acted on:

- 1. Abandonment of 131st Avenue Discussion regarding the Farmers Markets held at The Midnight Winds ensued. The property owner, Kevin Lindus will provide proof of liability coverage to include the Town for a sum of \$500,000. The Town needs to remove the culvert and blacktop to eliminate access of 131st Avenue from US Highway 8 and seed the ditch to meet the requirements of approval of the State to abandon. Motion to allow Midnight Winds to hold markets through end of September made by Supervisor Bryan, motion 2nd by Supervisor Johnson.
- 2. Cemetery Board opening to be filled by Betty Bergstedt. Motion by Supervisor Bryan to appoint Betty, seconded by Supervisor Johnson. Voice vote, motion carried.
- 3. Planning Commission Board Dale Schultz will serve another term, Coleen Tolliver's term is complete. Janice Carlson will replace Colleen, and serve on the Commission. Motion by Supervisor Bryan to reappoint Dale Schultz and appoint Janice Carlson, motion 2nd by Supervisor Johnson. Voice vote called. Motion carried.
- 4. Abandonment of Apple River Court Legal description needed for 330 foot roadway, final resolution and publication needed.
- 5. Town of Georgetown Fire Coverage need to complete a contract for the coverage.
- 6. 2021 Budget hearing to be scheduled in early October.
