***BIANNUAL CAUCUS- JANUARY 21, 2021***  
***612 US Highway 8***

Attendance: Chair Rick Scoglio, Clerk JoAnn Agne, Janice Frederickson, Dayton Frederickson, Justin Dunkin, Samara Duncan, Ansel Johnson, Charley Cran, Brian Johnson, Adam Jarchow, Barb Jarchow, Steve Arducer, Kerry Bryan, Jenna (Last name illegible), Julie Torgerson, Russ Torgerson, Walter Strey, and Janice Carlson.

Chairman Scoglio called the 2021 Bi-annual caucus to order at 7:00 p.m. Thursday, January 21, 2021. He announced that he was not a candidate for office and will run tonight's caucus. The Chair detailed the voting procedures and announced the positions that will be filled on April 6<sup>th</sup>. The four positions the Town is seeking candidates for are: (1) one Town Chairman, (2) two Town Supervisors and (1) one Town Treasurer.

Chair Scoglio asked if the Electors would like to make oral or ballot nominations. A motion was made by Adam Jarchow to use oral nominations. Motion seconded by Walter Strey. All in favor, motion carried.

Chair Scoglio asked for volunteers for Tellers. Jenna (last name illegible) and Samara Duncan were appointed tellers.

Chair Scoglio asked for nominations for **Town Chairman:** Kerry Bryan was nominated by Steve Arducer. Motion for support of Kerry Bryan, seconded by Charlie Cran. Hearing no further nominations, motion by Adam Jarchow to close nominations for Chair. Motion seconded by Walter Strey. Motion carried. On the ballot will be Kerry Bryan for Chair. Mr. Bryan accepted the nomination.

**Supervisors:** Russ Torgerson nominated Justin Duncan. Motion to nominate Mr. Duncan, motion seconded by Walter Strey. Adam Jarchow nominated Chad King as a Supervisor. Barb Jarchow seconded the motion. Ansel Johnson was nominated as Supervisor by Brian Johnson. Russ Torgerson seconded motion to nominate Ansel Johnson. Hearing no other nominations, motion to close nominations was made by Adam Jarchow, with a second by Steve Arducer. Motion carried. Chad King was unable to be present but was aware of possible nomination and will likely accept it.

**Treasurer:** Janice Carlson was nominated by Janice Frederickson. Motion to nominate Janice Carlson was seconded by JoAnn Agne. No other nominations were offered. On the ballot will be Janice Carlson. Ms. Carlson accepted the nomination.

A drawing was created to determine ballot order for the three Supervisor candidates. The candidate's names were placed in a basket and drawn out by Jenna (last name illegible). The first name drawn was Justin Duncan. The second name drawn was Ansel Johnson. The remaining name was Chad King. On the April ballot for Supervisor the names will occur in this order: Justin Duncan, Ansel Johnson, and Chad King.

The election is scheduled for April 6, 2021.

Having no further business, Chair Scoglio stated he would entertain a motion to adjourn. Motion by Adam Jarchow with Walter Strey seconding motion to adjourn. Motion carried. The 2021 Caucus was adjourned at 7:12 p.m.
