REGULAR MONTHLY BOARD MEETING
Monday, March 13, 2023

The **March Regular Board** Meeting of the Town was called to order at 7:00 pm by Chair Bryan.

All **present**: Chair Bryan, Supervisor Mullenbach, Supervisor King, Treasurer Carlson, Clerk Agne, Jon Fields, and Dan Waalen.

Approval of **Meeting Agenda**: Chair Bryan inquired if everyone had reviewed this evening's agenda. Supervisor King noted that upcoming events Tuesday, April 23 was an incorrect date. The Clerk noted it should be April 25. Motion by Supervisor Mullenbach to approve the agenda as corrected. The motion was seconded by Supervisor King. A voice vote was called. Motion approved.

Approval of Minutes: The draft minutes from the Regular February Board Meeting were reviewed. Supervisor Mullenbach noted that reference to Polk County should be clarified to the Sheriff's Department and a reference to the Township should read Nick's Trucking & Excavating. Motion by Supervisor Mullenbach to approve the minutes as corrected. The motion was seconded by Supervisor King. A voice vote was called. Motion approved.

Public Input: None.

Clerk's Report: LRIP still in need of Certification of Publication. Submission due in June.

Report by Treasurer: February Report was presented by Treasurer Carlson. A motion by Chair Bryan was made to accept the Treasurer's Report as given. Motion seconded by Supervisor King. A voice vote was called. The motion carried.

Apple River Solar: No new information.

BIL – April 7th submission for new funding round.

County Report: None.

Vouchers: Vouchers were reviewed. Motion by Supervisor King to approve the vouchers. Motion to approve, seconded by Supervisor Mullenbach. A voice vote was called. The motion carried.

Supervisor Reports: Chair Bryan reported that one area of concern regarding roads was 70th Street South of Highway 8 to Lincoln town line. A chip seal with spray patch was discussed. Consider using the County once their pricing is announced. There are a couple of outstanding driveway permits to complete. Treasurer Carlson provided information that the Town of Beaver sends out with Tax Bills. Will send out similar notice with 2023 Tax Bills and post on website.

Supervisor King and Supervisor Mullenbach: No report.

Election: Town Board non-contested races; Amery and Unity School board(s); Supreme Court; and 3 Referendums.

Fire Department - 166 Total Fire Calls for 2022. 124 calls - Apple River; 29 calls - Georgetown; 2 - Johnstown; and 11 other. One factor are medical calls from individuals who call each month repeatedly. A one-ton Brush truck was purchased to replace the existing truck.

Planning Commission: No meeting.

Items to Be Reviewed and/or Acted Upon:

Dale Smith Rezone Application – Due to existing violations and concerns expressed, Chair Bryan **moved** to revoke previous approval and disallow the rezone. Motion **seconded** by Supervisor Mullenbach. A voice vote approved the motion unanimously.
